

Sit By Me Terms of Service / End User License Agreement

Last updated: July 29, 2026

Welcome to Sit By Me. These Terms of Service (“Terms”) govern your access to and use of the Sit By Me mobile application and related services (collectively, the “App”), operated by Sit By Me (“we,” “us,” “our”). By creating an account or using the App, you agree to these Terms. If you do not agree, do not use the App.

1. Eligibility

You must be at least 13 years old (or the minimum age of digital consent in your jurisdiction) to use Sit By Me. By using the App, you represent that you meet this requirement and that all information you provide is accurate.

2. Your Account

You are responsible for maintaining the confidentiality of your account credentials and for all activity that occurs under your account. Notify us immediately if you suspect unauthorized use of your account.

3. License to Use the App

Subject to these Terms, we grant you a limited, non-exclusive, non-transferable, revocable license to download, install, and use the App on a device you own or control, for your personal, non-commercial use.

You may not: - Copy, modify, or create derivative works of the App - Reverse engineer, decompile, or disassemble the App - Use the App for any unlawful purpose or in violation of these Terms - Attempt to gain unauthorized access to other users’ accounts or data - Use the App to harass, threaten, or harm other users

4. User Content and Conduct

You are solely responsible for the content you post or share through the App, including your profile picture, bio, and messages sent to other users. You agree not to post content that is illegal, harassing, hateful, sexually explicit, or otherwise inappropriate.

We reserve the right to remove content or suspend/terminate accounts that violate these Terms, at our discretion.

5. Location Services

The App uses location data, with your permission, to provide core features such as showing nearby events and Connection Points. You can control location permissions through your device settings; disabling location may limit certain features.

6. Friends, Messaging, and Interactions with Other Users

Sit By Me allows you to connect with other users, view their shared profile information, and exchange text messages. You are responsible for your interactions with other users. We do not verify the identity of users and are not responsible for their conduct on or off the App. Use good judgment when meeting people or attending events connected through the App.

7. Third-Party Services

The App may integrate with third-party services (such as Meta/Facebook) for features like advertising, login, or analytics. Your use of those services is subject to the applicable third party's own terms and privacy policy.

8. Termination

We may suspend or terminate your access to the App at any time, with or without notice, for conduct that violates these Terms or is otherwise harmful to us, other users, or third parties. You may stop using the App and delete your account at any time (see our Data Deletion Instructions).

9. Disclaimers

The App is provided "as is" and "as available," without warranties of any kind, express or implied. We do not guarantee that the App will be uninterrupted, error-free, or secure. Sit By Me is a platform for discovering events and connecting with others; we are not responsible for the safety, conduct, or outcome of any in-person meeting or event arranged through the App.

10. Limitation of Liability

To the fullest extent permitted by law, Sit By Me and its affiliates will not be liable for any indirect, incidental, special, or consequential damages arising from your use of the App.

11. Changes to These Terms

We may update these Terms from time to time. If we make material changes, we will provide notice through the App or other reasonable means. Continued use of the App after changes take effect constitutes acceptance of the updated Terms.

12. Governing Law

These Terms are governed by the laws of the State of Wisconsin, without regard to conflict-of-law principles, unless otherwise required by applicable law in your jurisdiction.
